



PASTOR'S REPORT

Beloved Partners in Ministry,

It seems hard to believe that 2024 has come to a close and 2025 has already begun. As I look back over the events of the past year, I am overwhelmed by the love and support that so many faithful members and friends have shown for Westminster Presbyterian Church. We accomplished so many wonderful things in our church building and have continued to expand our welcome and outreach into the community. None of this work is possible without the volunteers who make this place what it is.

In true Pauline fashion, he ends his letter to the Thessalonian church with a rundown of reminders of what is required of a faithful community. I hope that as you read through this report, you'll see the work we do together reflects that call in many ways, even as we strive each week, each year, to fall closer in step following Jesus' footsteps as disciples.

"Live in peace with each other. Comfort the discouraged. Help the weak. Be patient with everyone. Make sure no one repays a wrong with a wrong, but always pursue the good for each other and everyone else. Rejoice always. Pray continually. Give thanks in every situation because this is God's will for you in Christ Jesus. Don't suppress the Spirit. Don't brush off Spirit-inspired messages, but examine everything carefully and hang on to what is good."

1 Thessalonians 5:13b-21 (selected verses)

For me, serving alongside of you as your pastor, I saw the good work of the Spirit reflected in your WELCOME and GENEROSITY.

In addition to the warm welcome members and visitors receive for every worship service, we welcomed over 350 people from Bay City for our second annual End-of-School block party. With the help of a grant from the Bay Area Community Foundation, we opened our doors again this year helping families to kick off the



summer by kid-centered activities, crafts, and a meal. There were eight community organizations on hand to share the resources they offer to families. One organization, after seeing our event promoted, called us the weekend of the event asking if we had room for them to participate! I think this speaks volumes to the reputation our church has in the community.

We also welcomed neighborhood youth in August for an "On the Road" Vacation Bible School in a partnership with Bay Shore Camp and Conference Center. This all-day camp experience was staffed by energetic young adults who helped us share Jesus' love in a safe and fun environment.

Through our conversations and exploration into the Matthew 25 focus of systemic poverty,

Westminster has taken a huge leap of faith as we began to welcome our neighbors experiencing hunger in a new way. In June, our pantry expanded from a single closet of food to an entire room, filled with shelves where neighbors in need can shop for their own food. Through a private donation and a grant, we received double-door freezer and refrigerator units. Because of your willingness to support and try something new, our pantry has gone from helping around 25 families a month, to providing food for an average of 135 families every month!

These are just a few of the examples of Westminster's WELCOME, none of it is possible without your GENEROSITY. Week in and week out, you support the ministry of the church through your gifts and your presence. 2024 was also a year of extravagant GENEROSITY, that helped us to provide these opportunities of WELCOME.

During the Season of Lent, the congregation was challenged to help fill the pantry. This was well before we had the vision of moving out of our closet, but you all responded in such a way that in 6 weeks we outgrew that space and had an abundance of food to share! As food expenses have climbed, the congregation has responded with continued donations to help support this much needed ministry.

When a member heard that due to the camp atmosphere of Vacation Bible School this year, we were asking families to help cover the cost, an anonymous donation was made to fully cover the cost for families so that any child that wanted to participate would be able to.

When another member heard that the food pantry needed freezer space so that we could offer meat and frozen vegetables to our guests, they generously purchased the freezer for the pantry.

Late in the year, an extremely generous anonymous donation was made to the Capital Campaign, allowing us to bring the balance of

our loan from the remodel to under \$40,000. We are hopeful to be able to pay this loan off in 2025, several years ahead of schedule.

These are just a few examples of the extravagant generosity you ALL display in supporting God's work through Westminster. No matter how big or how small, your gifts make the stories on the pages of this annual report possible.

As we step into 2025, I am filled with gratitude and anticipation for all that lies ahead. Together, we have witnessed the transformative power of God's Spirit working in and through Westminster Presbyterian Church. The stories shared in this report are a testament to what happens when faith meets action, and I believe they are only the beginning. Let us continue to WELCOME all with open arms, to serve with compassionate hearts, and to give GENEROUSLY of ourselves as we strive to reflect Christ's love in all that we do. Thank you for your faithfulness, your energy, and your commitment to this community of faith. With God's guidance and your partnership, I look forward to the blessings and opportunities that 2025 will bring. May we continue to be a church that boldly shares God's love with one another and with the world.


PARISH ASSOCIATE'S REPORT

On the first Sunday of 2025 during worship, we read a passage from Acts (2:43-47) that tells of the early church:

⁴³ Everyone was amazed by the many miracles and wonders that the apostles worked. ⁴⁴ All the Lord's followers often met together, and they shared everything they had. ⁴⁵ They would sell their property and possessions and give the money to whoever was in need. ⁴⁶ Day after day they met together in the temple. They broke bread^[a] together in different homes and shared their food happily and freely, ⁴⁷ while praising God. **Everyone liked them**, and each day the Lord added to their group others who were being saved.

Those words caused me to reflect on the life of the church of yesterday and the church of today, especially the phrase "everyone liked them." Now we all know it is impossible for everyone to like us – as individuals or even as a church. If we stand up for what we believe and that happens to be at odds with what another person believes, then it is possible that we will not be liked. But as the Apostle Paul adds in his letter to the Romans (12:18) – "do your best to live at peace with everyone."

Maybe not liked because of what we believe but at least not disliked because of how we express what we believe. Or as Paul said, "do your best to live at peace with everyone." And is that not an appeal to the message of Christ. In these days of polarization, it can be hard work to live at peace with everyone; I know it can be difficult for me, and from what I hear from some others, it is difficult for them too. So then when I read this same passage from The Message, a Bible translation by pastor and scholar Eugene Peterson, he adds another dimension to that concept of "being liked" and "living at peace." He writes: Don't hit back; discover beauty in everyone. If you've got it in you, get along with everybody. Don't insist on getting even... Discover beauty in everyone.

I'm completing the writing of this report on the day of President Jimmy Carter's funeral - a man of deep faith. Though he spent 8 years as a governor and a president, he lived his other 92 years as an ordinary child and man who lived his faith, and in the living of his faith, became a much-admired man/liked man – even by those who had a different world view/political view than his. Mr. Carter, as a follower of the Lord, it would seem "sought to discover the beauty in everyone." And for that he was liked by most everyone. And if not liked, respected for the work that he did as a humanitarian here in the United States through Habitat for Humanity, in third-world countries through health initiatives, and in sharing his Christian beliefs as a Sunday School teacher who taught once monthly at his small home church in Plains, GA that drew people from all over the country.

As I reflect on this past year at Westminster, I marvel at the growth in ministry that has happened when we discover beauty in everyone and like them. Pastor Jamie's report captures the excitement and hard work of some of those events and ministries of welcome and generosity. Faith in action...love in action...so that we may discover the beauty in everyone, in each other. I am grateful for being a partner with you in this journey of faith.

WORSHIP COMMITTEE

The Worship Ministry is responsible for the activities of the congregation related to the regular Sunday worship experience, along with the music program, such as bell choirs, children's choir, youth choir, chancel choir, and organist. Other areas include baptisms, special events, and services.


We invite liturgists, communion servers, and Westminster At Work presenters to participate in the Sunday services.

The church services continue to be recorded to stream on the church website, Facebook, and Youtube.

For most of our Sunday worship services this year, we continued to use the Follow Me curriculum that linked our theme in worship with our educational classes. In January the theme was "Worship God", where we talked about the importance of what we do to worship together and in our individual lives. Our Lenten series this year centered around Peter's journey as a disciple and was titled, "Wandering Heart." As the world awoke from its winter slumber in April, we embraced our call to "Care for Creation."

Our Summer series centered around the "Faces Of Our Faith," offering us a look at some less well-known Bible characters, helping us to place ourselves in the Biblical story. In August we thought about "Soul Food," the things that feed us and feed our souls. To kick off the program year in September, we were invited to "Walk Humbly" with God. Beginning on All Saint's Sunday, our final theme before Advent reminded us of our congregational call to "Comfort Those Who Mourn." Finally, in the weeks of Advent and through Christmas, we were encouraged to begin again, with the beautiful images and liturgy from A Sanctified Art called, "Words For The Beginning." Each of these series focused us in worship and invited our Christian education classes to study the same topics.

Several of our "new" traditions continued in 2024. On the first Sunday of the year, worshipers received a "star" word written on a wooden



cutout. This word is intended to be a guiding word for the year, reminding people to look for God's presence and guidance as they read or have an experience with their word.

On the Sunday before Thanksgiving, we held the "Hanging of the Greens" service. During this uplifting service the church sanctuary was decorated for the Advent and Christmas seasons as we heard the history and legends behind the symbols used to adorn our building and homes during the holidays.

One new tradition has been having the children bring in the light at the beginning of worship, and taking the light into the world at the end of worship.

Dawn Auger, Chancel Choir Director continued to lead our adult choir and organized the special music for church musical performances. In December the choir performed the fun-filled and challenging cantata "Glorious Light Of Christmas."

Seth Cunningham accompanied on piano and organ during choir practice as well as during church services.



Spiritual Growth & Faith Formation


To follow Jesus faithfully, is to be in community with other disciples, journeying together as life-long learners. We are all at different stages of that journey, sharing our perspectives, experiences, questions, and doubts with our fellow travelers. The "mission" of the Spiritual Growth and Faith Formation Ministry is to provide opportunities for us to grow in our faith as we journey together. Some of the ways we did that in 2024 include:

January Series – three weeks of hearing challenging and informative speakers as we joined in Calvin University via the internet. A small but faithful group watched the series together in the Session Room, meeting each day from 12:30-1:30. Others also took advantage of the opportunity to watch from home and then joined in on the Thursday gathering where we took time to discuss the week's speakers. The series speakers included a sociologist speaking on "Poverty, by America;" a physician on "The Lost Art of Dying;" Al and the church, as well as bakers, poets, and musicians.




Lunch and Learn/Lunch and Laugh - This year

we added to our noon-time "Lunch & Learn" series, an alternative, "Lunch & Laugh" – a time of more informal conversations and activities. During our "Lunch & Learn" gatherings we had several speakers from the community including attorneys helping us better understand the legal system, as well as informative presentations on dementia, and information on food insecurity in Bay County. "Lunch & Laugh" included informal conversations over a catered lunch from one of our local restaurants. In 2025 we are adding game time to the mix when we gather over lunch.



FYI Happenings/Book Groups – Our FYI Happenings series

expanded to include opportunities for a writers group – Star Gazers & Soul Searchers – those who wanted to meet with others and explore through writing ideas and feelings that encouraged us to "pay attention" to the world around us and God's presence in our daily lives. We also have a band of faithful book readers who meet almost weekly to talk about books we have been reading together, including Nine Essential Things I've Learn about Life by Harold Kushner and Mostly What God Does by Savannah Gutherie.



In addition this summer we reconvened to complete our viewing of the "Anne of Green Gables" movie series.

Spiritual Growth & Faith Formation

Sunday morning and Thursday evening Bible Study – Two groups are offered so people have different options for group Bible study, a morning in-person group and an evening option via Zoom. Sometimes the two groups used the same Bible study focus, especially during both Lent and Advent. This past year we also added to the mix the "Feasting on the Word" Bible study series in which we focus on the same Bible passages that are being used in Sunday morning worship.

Summer Book and Brunch – This summer, we tackled a difficult, thought-provoking book by Matthew Desmond, *Poverty, By America*. As we broke bread together, we were challenged by the systemic aspects of poverty that make economic mobility difficult.

Annual Fall Retreat – This year's retreat at Bay Shores invited us to become "Awakened Travelers." In between videos with PBS travel favorite Rick Steves linking his travel experiences to his own faith, we reflected together on scripture, through song and crafts, and enjoyed one another's company on our own journeys of faith.

Coffee and Conversations – By request, we continued to provide the opportunity for those who are experiencing grief to get together over a cup of coffee or tea as we shared and listened to each other's experiences of grief, learning from each other and providing support as we recognize the similarities and differences in our journey through grief. We meet generally on the fourth Tuesday of the month at 1:30 in the Lounge. Because the holidays bring their own poignancy, we also had a special gathering in December when we considered "Whispers of Wisdom: Continuing Conversations around Grief and Loss."

Mission Partnerships

"I was hungry and you gave me food to eat. I was thirsty and you gave me drink." Food insecurity affects 29% of Bay County residents, and 14% of Bay County residents live below the poverty line. That reality in our own back yard fueled a redirection in 2024 for the Mission Partnerships Committee and our charge as a Matthew 25 church. A re-defined Westminster Community Pantry opened

Community Pantry opened in June. Patrons can visit once a month, are accompanied through the pantry, and can select products they need and will use. New partnerships with Hidden

even joined us for worship.

Harvest and the Food Bank of Eastern Michigan (FBEM) offer deep savings and/or free products and fresh produce. Donations of money, food, fresh produce, and volunteer hours come from within and outside of our church membership to meet the need for food and hygiene products. The redesigned pantry also gives us the opportunity to share our time and listening ears with our visitors. The result? Since June, we have served over 945 families, 475 new families, and distributed more

than 32,000 pounds of food. A few visitors have

You can also see the faith-in-action ministry of Westminster volunteers at the Salvation Army. Once a month, we help prepare and serve food to the hundreds of people seeking a free home-cooked, nutritious meal. We also sent two small teams to the main packing and distribution center for the FBEM in Flint to help sort and pack thousands of pounds of food.

Through our connection with the Bay County Emergency Food Network, we received names to distribute 25 boxes of food through the Back-to-School Program and 100 Thanksgiving Food baskets which provided a bountiful holiday feast for nearly 350 people.

At Christmas time, the Community Pantry supported 89 families with a special holiday

food box purchased through the FBEM. These boxes totaled nearly 4,800 pounds of food.

One of our longest-running Mission partnerships, the Food of Faith ministry, a collaborative effort with Messiah Lutheran Church, continues to serve the residents of Bay City a homemade meal each week. While many organizations assist in this endeavor,

Food insecurity affects 29% of Bay County residents, and 14% of Bay County residents live below the poverty line. Westminster volunteers faithfully contribute their time and energy to this vital initiative weekly and oversee 8+ meals a year. The need has grown over the years, and they now

provide approximately 240 meals EVERY WEEK.

Ministry to the hungry is but one aspect of mission work outside of the church. 75 Angel Tree gift tags filled by our congregation brought joy to the Christmas holiday for the needy. Westminster partnered with First Presbyterian and Sleep in Heavenly Peace for a "bed build" early in the year. A team of 60 volunteers cut, sanded, stained, and branded the materials needed to provide beds for children throughout the area who otherwise would have no bed of their own to sleep in.

As in past years, monetary donations were also given for families in crisis, support for the Good Samaritan Rescue Mission, Sleep in Heavenly Peace, Children's Grief Center, Child Abuse and Neglect Council, and Foster Families.

How blessed we all are to be part of this work God calls us to. If you feel moved, come join our committee and experience the joy we feel through service.



Mission Statement: To nurture fellowship among all members of Westminster Presbyterian Church and to introduce WPC to the community through outreach events; utilizing social media, the church website, and other advertising methods.

The Fellowship and Outreach Ministry works to keep Westminster connected—both within our congregation and with the community—by creating opportunities for fun, fellowship, and, of course, FOOD!

We began 2024 with the annual soup luncheon and bake sale, held on February 4th following the Annual Congregational Meeting. A wide variety of soup and homemade bread was served. The youth held a bake sale to supplement the meal.

Just two weeks later on Stewardship Sunday, we celebrated the gifts of the congregation with a light lunch featuring an array of sandwiches, brownies, and beverages. This meal is offered as a heartfelt way for the Stewardship Ministry, Session, and Fellowship Ministry to thank the congregation for their continued generosity and commitment.

June brought the second annual End of School Block Party, an event led by our youth group with support from a Bay Area Community Foundation grant. The day was filled with games, activities, food, and participation from local organizations that provide resources for children and families.

On an unseasonably damp and cool August evening, seventeen brave souls attended Faith Night at the Great Lakes Loons game.

In September, we launched the Sunday School year with our always-popular Ice Cream Social, while October followed with the highly anticipated Harvest Party and Chili Cookoff, a fun-filled afternoon for all ages.

As Advent began, we decorated the sanctuary during a special worship service, reflecting on the meaning behind the symbols of the season. The Advent Dinner and Workshop offered yet

Personnel Committee

Cards: (Marilyn Bechtel, Chairperson)

Cards are mailed to church members and their families for birthdays, hospitalizations, weddings, anniversaries, baby congratulations, sympathies, and to commemorate 50-year members at Westminster. Thinking of you and thank you notes are frequently sent to church members. Cards are also given to new members of the church family, welcoming them into God's ministry at Westminster.

Communion: (Nancy Berta and Amy Weatherwax, Chairpersons)

The Deacons are responsible for setup and cleanup for every communion service as well as stocking necessary elements and supplies. Each Deacon typically serves communion two or three times a year as directed by the Session's Worship Ministry. Deacons also provide communion to homebound members immediately following Communion Sunday worship. This is intended to create a feeling of inclusion in the entire Westminster family on Communion Sunday. With the onset of the COVID-19 pandemic, changes have been made to promote infection-control practices. Recently, we have transitioned from packaged elements to served elements utilizing fresh bread and juice served at the table in the front of the sanctuary.

Mission Partnerships: (Len Petroff and Irene Esckilsen, Chairpersons)

The Deacons support the Mission Partnerships (formerly Crisis Committee) financially, and have at least one active member on the committee. A committee member serves on-call each day to receive calls and give appropriate assistance such as purchasing groceries, restoring or avoiding loss of utilities, and assistance with housing and transportation. Our food pantry is open two days a week and provides groceries to those asking for assistance. In addition, Thanksgiving baskets are delivered to families in need, and the Giving Tree provides support to under-privileged children at Christmas.


STEPHEN MINISTRY

FINANCE COMMITTEE

In 2024 Westminster's finances continue to be affected by rising costs. We have lost many faithful and generous church friends due to death. These factors led to a deficit in the Operating Fund at the end of the year, despite many of our committees coming in under budget. Investment income is used to make up this difference.

In 2016 we took out a loan to renovate part of the building. At the start of the year, our loan with Presbyterian Investment and Loan Program had a balance of \$152,543.52. As the year comes to a close, our balance sits at \$35,641.00. Thanks to endowment income, generous individual donations and pledges to the Capital Campaign, we feel confident that we can pay off the loan in 2025, almost ten years early.


Quast Janke completed their review of our financial statements in April and found no issues. Their report is included on page 35. They will begin our 2024 review shortly.

As of September 30, 2024, the WPC Endowment had a market value of \$313,005.79. Session continues to earmark the interest earned toward the PILP loan. After the loan is repaid, WPC Endowment interest earned will be reinvested into the Endowment itself. Westminster is also

the beneficiary of the Vernon E. and Ruth Short Educational Endowment, which has a balance of \$221,819.60 as of September 30, 2024. Interest from this Endowment is paid to the Short Endowment Interest Fund held at New Covenant Funds. In 2024, interest of \$8,009.18 was received, and at December 31, 2024, the fund balance was \$38,579.42. See page 18 for a report on how funds disbursed from the Interest Fund were used.

Westminster also has three other investment funds with New Covenant. At December 31, the WPC Investment Fund has a balance of \$166,636.31, the Birthday Investment Fund has a balance of \$3,165.45, and the Pastoral Housing Investment Fund has a balance of \$65,042.07. The Church is also the beneficiary representative of funds held at the Bay Area Community Foundation. Interest from those funds is used to pay down the PILP loan.

ANNUAL MEETING OF THE CORPORATION JULIE KELLY, PRESIDENT, BOARD OF TRUSTEES

The meeting was called to order with an opening prayer by Pastor Jamie Milton. President of the Corporation, Julie Kelly was called forward.

<u>Motion</u> was made, seconded and approved for the Westminster Presbyterian Church of Bay City, MI, meeting on Sunday, February 4, 2024 adopts all acts of the Congregation. Motion passed. <u>Motion</u> was made, seconded and approved to close this Corporation meeting. The Moderator, Pastor Jamie Milton closed the meeting with prayer at 11:40 a.m.

BYLAWS OF THE CONGREGATION OF

- 1. The Westminster Presbyterian Church of Bay City, Michigan, being a particular congregation of the Presbyterian Church (U.S.A.), recognizes that the Constitution of said Church, is in all its provisions, obligatory upon it and its members.
- 2. There shall be an annual meeting of the congregation in the Church edifice within the first six weeks of the calendar year for the transaction of any business properly coming before such meeting.
- 3. Special meetings may be called by the session or the presbytery. Such calls shall state clearly the purpose of such special meeting, and no other matter, save that specified in the call, may be considered.
- 4. Public notice of the time, place and purpose of all meetings of the congregation shall be publicly announced from the pulpit on two successive Sundays preceding the meeting.
- 5. One of the pastors shall preside. If the church is vacant, or if the pastors and the ruling elders agree that the subjects to be discussed require it or if the pastors are ill or are otherwise unable to be present, a minister of Lake Huron Presbytery shall be invited by the session to preside. This invitation shall be cleared through the Committee on Ministry of Lake Huron Presbytery.
- 6. The clerk of the session shall be secretary of the meetings of the congregation. If unable to attend, the session shall designate someone to act as secretary.
- 7. The members of the Church who are entitled to vote shall be active members in good standing as defined by the usages and rules of the Presbyterian Church (U.S.A.), regardless of age.
- 8. As required by the laws of the State of Michigan, only members of full age (18) shall be eligible to vote on questions dealing with property and matters that are strictly the business of the corporation. Otherwise, all active members of the church are eligible to vote at all stated and special meetings of the church. Voting by proxy is not allowed.
- 9. Meetings shall be conducted in accordance with the General Rules of Judicatories adopted by the General Assembly of the Presbyterian Church (U.S.A.), so far as they apply, and when they do not apply, according to usual legislative rules of order.
- 10. All meetings shall be opened and closed with prayer



- 11. A quorum shall consist of the moderator, clerk of session, those present and voting.
- 12. There shall be no less than 12 and no more than 18 ruling elders divided into three classes, one class of whom shall be elected each year for a three-year term, at the annual meeting of the congregation. No ruling elder shall serve on the session for consecutive terms, either full or partial, aggregating more than six years; and shall be ineligible to be elected to a new term until one year has elapsed.
- 13. There shall be 15 deacons divided into three classes, one class of whom shall be elected each year for a three-year term, at the annual meeting of the congregation. No deacon shall serve on the board of deacons for consecutive terms, either full or partial, aggregating more than six years; and shall be ineligible to be elected to a new term until one year has elapsed.
- 14. Vacancies on the session or board of deacons may be filled at a special meeting of the congregation or at the annual meeting, as the session may determine.
- 15. A quorum for session meetings shall be one-third of its membership.
- 16. There shall be a representative Nominating Committee chosen in accordance with Rule 17. This committee shall bring to the annual meeting nominations of one eligible person only for each officer to be filled. Additional nominations of qualified persons may be made from the floor by any eligible voter.
- 17. The Nominating Committee shall consist of the following:
 - Two (2) elders, one of whom shall chair the Nominating Committee
 - One (1) deacon
 - Between Four (4) and Seven (7) members-at-large

The elders and the deacons shall be elected by the body they represent. Between four and seven members-at-large may be nominated by the nominating committee or from the floor and elected by popular vote at the annual meeting of the congregation.

- 18. These bylaws may be amended subject to the charter of the corporation, the laws of the State of Michigan, and the Constitution of the Presbyterian Church (U.S.A.) at any annual meeting or at any special meeting by a two-thirds (2/3) vote of the voters present provided that a full reading of the proposed changes or a printed distribution of the same shall have been made in connection with the call of the meeting.
- 19. These bylaws or the charter of this corporation may not be amended contrary to or so as not to include the provisions of the Constitution of the Presbyterian Church (U.S.A.).
